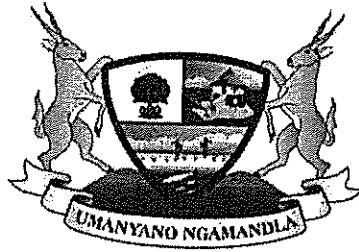

REQUIREMENTS FOR A SERVICE PROVIDER TO REPAIR AND MAINTAIN GARDEN POWER TOOLS – 12 MONTHS.

All tools & equipment has to be properly maintained so that the workers will be not endangered. Health and Safety regulations requires continuous inspection of tools and machines before use to keep them safe, usable condition, limit downtime and extend productivity defined in the operational procedures. Maintenance schedule recommended by manufacturers vary according to type of machinery and will be provided to the service provider.


