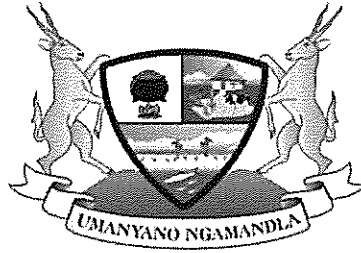



Terms of Reference: for the reviewal of Tourism Development Plan

1. Introduction and Background

The Tourism sector is one of the sectors that needs updated information on the best practices that need to be followed to stay relevant to the field, such information is somehow difficult to access particularly to local tourism product owners or role players. Mbizana is a coastal municipality with an amazing coastline, a 22 km stretch from Mthamvuna River to Mtentu River that has a lot to offer to the tourists. It is important that Bizana's coastline as well as inland attributes receives the necessary exposure in order for the region's tourism to expand.

The Mbizana Local Municipality wants to bridge the gaps on not updated information on new developments occurred since the development of the current plan, and budgeted for the reviewal of Tourism Development plan that will serve to generate contemporary information and data, applicable strategies, learned lessons, for diverse tourism systems in anticipation of future changes and technologies applied in tourism. The ideal for the reviewal of the plan is for both tourism role players and policy makers to be updated about the information that other role players have gathered and strategies they have adopted to respond to the ever changing tourism sector.

Currently, mbizana is not utilizing regions entire coastline and inland tourism aspects to tap into domestic and international markets. There are numerous product offerings that exist both inland and on the coastline. It is however vital to identify hidden gems that are yet to be discovered.

2. Project Objectives

- ▶ The main purpose of the project is to facilitate the review of a Comprehensive and well co-ordinated Tourism Development plan and implementation framework that will guide the interventions and strategies to improve the economic potential of tourism in Mbizana also identify a catalyst project and compile a bankable business plan for that identified project.

3. Scope of Work

Competent service providers are hereby invited to submit proposal to review tourism development plan:

A service provider is being sought to undertake the following:

- ▶ Manage, facilitate and co-ordinate the review of an implementable 'Tourism development plan' in accordance with the TOR
 - ▶ Ensure all relevant stakeholders are involved and informed about process and progress
 - ▶ Ensure co-ordination and integration with all plans being developed
 - ▶ To provide technical assistance.
 - ▶ To ensure alignment with available policies and legislative framework
 - ▶ SWOT analysis
 - ▶ Current Tourism Supply and Demand analysis
 - ▶ Identify key strategic tourism systems, funding instruments and initiatives.
 - ▶ To develop strategies on institutional arrangements
 - ▶ Develop implementation plan.
 - ▶ Identify and Develop a business plan for one catalyst tourism project.

4. Specific Objectives

The overall objective is to assist the Mbizana Local Municipality in finding sustainable solutions to the declining economy, increase in poverty and a shrinking tax base by providing a proposal for the promotion of tourism as a major economic contributor to the local economic development in the Mbizana Local Municipality.

- ▶ Alignment of the Framework with National, Provincial & Local pieces of legislation for responsible tourism (Tourism act 72 1993, White paper, NTSS, ECPTA 10 of 2010, National Heritage resources act 25. of 1999, NEMA). Coastal and Marine Tourism (CMT).
- ▶ Guide the interventions and strategies to improve the economic potential gain tourism and empower of Mbizana area.
- ▶ Spell out the economic vision, objective and targets of Mbizana Tourism for the next five (5) years, with **2020/2021** as the base year.
- ▶ Give clear indication of the strategies that will be developed as well as programmes to be implemented by the municipality in addressing economic challenges facing the municipality

5. Project Methodology

The service provider must provide a detailed outline of the methodology to be used detailing how each of the deliverables is to be achieved.

6. Project Deliverables

The final project deliverables to be produced on a phased basis over a stipulated period. In accordance with the relevant standards and procedures for professional practice, and scope of work, the professional service provider will submit and make oral presentations on the following output and deliverables to the municipality.

On conclusion of the project a final report is to be delivered in hard copy and in CD format containing each of the following:

- ▶ Outline of consultation process elicit input from key and effected stakeholders;
- ▶ Gather all required information
- ▶ Carry out relocation inspections to determine the existing uses, applicable legislations in a manner that will ensure accurate results
- ▶ Two reports (First draft and second Draft)
- ▶ Circulate to the external stakeholders for comments and inputs
- ▶ Submit final copy with implementation plan

7. Expertise Required

The service provider will be required to provide a team of experts which incorporate at least some of the following expertise:

- ▶ The service provider must demonstrate understanding of the terms of reference.
 - ▶ The quotation must be accompanied by a proposal on how the project will be undertaken.

- ▶ The service provider must have experience in the tourism industry.
- ▶ The service provider must have at least over three years' experience in tourism development.
- ▶ Knowledge of the National Development Plan 2030 and relevant national tourism development plans and strategies
- ▶ The service Provider is also required to include qualifications, CV and company profile as these are pre-requisite.
- ▶ Extensive project management and implementation capacity.
Knowledge of tourism as a Service industry and profound experience in facilitation.
- ▶ Knowledge of the South African and Eastern Cape economy.

8. Reporting

The successful bidder will be required to enter into a Service level Agreement with the Municipality the contracting party, detailing the scope of work to be completed, together with time frames and cost implications.

An inception report will be submitted by the Service Provider within two weeks of the signing of the contract, outlining a detailed implementation plan for the project

Thereafter, monthly progress reports will be submitted to the Project Steering Committee until successful conclusion of the project. The Steering Committee will include representatives from the Mbizana Local Municipality and other relevant identified role players. The Service Provider will be required to undertake formal presentations to the Steering Committee.

A detailed proposal outlining the reporting and project delivery plan to be included in the service providers bid to undertake this assignment.

9. Time Schedule

It is envisaged that the timeframe for conclusion of the project will not be more than 3 Months.

Payment terms will be negotiated on the basis of completion of project milestones and will be outlined in the Service Level Agreement.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

2. DEFINITIONS
